The publishing activities are managed through Dmedia Group that controls Netweek, the first circuit of local weekly magazines in Lombardy. With a circuit that includes 17 local titles and the leading regional weekly in terms of circulation, “Milan Metropolis – Lombardy in Europe” (Milano Metropoli – Lombardia in Europa), Netweek has a circulation of 190,000 copies and one million readers every week. Netweek also produces and sells editorial content for national media and local institutions.
